11. Welcome to Members of the Company

The Chairman invited the President of SIFRE, Revd Cliff Reed, to open the meeting. Cliff welcomed the members of the company to the meeting and commented on the extensive range of activities undertaken by SIFRE in the last year. The Chairman then wished Cliff well as he looked forward to his imminent retirement, thanked him for all he had done through the years and welcomed his intention to continue to be SIFRE's President.

13. Minutes of the Seventeenth AGM held on 6th September 2011

Minutes of the 17th AGM had been made available on the SIFRE web site and copies were tabled before the start of the meeting. These were accepted as a true and accurate record of that meeting and were signed off by the chairman.

14. Matters arising

The Executive Officer reported that the revised Memorandum and Articles had been deposited with Companies House and the Charity Commissioners and were now operational.

15. The Report of the Board of Trustees

The chairman referred the meeting to the annual report of directors and highlighted various issues within it. The meeting accepted the report nem con. The Chairman emphasised our gratitude to Suffolk New College for past support and to University Campus Suffolk for their provision of premises and services and ongoing support. He also referred to our lecture series and expressed appreciation to Mike King for his contributions to the seminar series and to David Sharp for his work as tutor for the NOCN classes. He expressed gratitude to all staff for their input during the last year.

16. Treasurer's Report and presentation of the accounts for 2011-2012

The Treasurer reminded the meeting that the Annual Report Accounts for 2011-2012 are presented in the required format for Companies House and the Charity Commissioners. He spoke to an abbreviated version of these in which the unreserved and reserved funds had been subsumed into one, and notional transactions had been omitted.

Referring to the Balance Sheet, he reported that EoY accounts balanced and explained that of the closing balance, approximately £10K is held as cost value of stock (games and books) – the cash assets of SIFRE being about £28K. The possible income from the sale of our stock is in the region

of £47K

The abbreviated statement of financial activities has three columns of figures, the first relates to 2010-2011, the middle column relates to the year in question 2011-2012 and the right hand column is the proposed budget for 2012-2013. SIFRE's funds reduced by £11K in this last year and the budget predicts that they will reduce by a further £8 in this present year.

He expressed his opinion that it is unlikely that we will receive any core funding in the foreseeable future and said he was sceptical about searching for project funding as we would need to secure about £80K for us to legitimately retain £10K in house.

He reported that the Board had agreed not to change our membership fees because many are paid by standing order and asking members to change these is difficult and could cause some to cancel the SOs they had. He reported that his appeal for donations when he sent out the membership renewal notices in August was getting a positive response. (For the first seven years of its life, SIFRE was in receipt of generous covenanted income from many of its founding members.)

Considering the present financial position of the country and compared with many other voluntary sector organisations, he observed that the financial position of SIFRE remains reasonable but the future is looking less certain. SIFRE continues to receive income from sales of its handbook and game and it has received income from EEFA related to work done by SIFRE members. Its other source of income from membership fees remains steady but much of this income is required to prepare and post mailings to its members although more use is being made of emailings.

In this last year, funds set aside for staff salaries together with income from sales and from EEFA have largely met expenditure on salaries. SIFRE's reserve fund of £30K, accumulated from funds given to us to enable us employ staff and which was established when SIFRE employed 3 plus persons as officers, remains intact. It is the aim of SIFRE to have general reserves sufficient to cover expenditure for a forward period of three months. At a minimum SIFRE needs to maintain general reserves that are sufficient to meet legal liabilities in the event of SIFRE's dissolution. Based on actual expenditure for 2011-2012 this equates to a desired reserve of £5K. The Board has agreed that apart from retaining a £5K reserve, this money should be used to cover staff cost as this was the intent of its donors.

At a time of National financial uncertainty, we will seek to secure funds to employ staff but we continue to be aware that this may not be possible in the next year or so. He related that he was recently told by one national charity that they have stopped core funding and are only supporting the relief of hardship in the community.

SIFRE is committed to doing those things it believes in and it intends to play a significant role in organising and running events during National Inter-Faith Week (this week was inspired by 'Face to Face and Side by Side', a government report).

SIFRE has slimmed down its operation and is again a largely voluntarily run organisation. It is thus less susceptible to the financial ups and downs of the country and county and can continue to deliver a professional service to the people of Suffolk for very little cost and with little fear of financial doom.

The Board would like to register its appreciation to Suffolk County Council for their past financial support and their indirect support through a Service Level agreement via EEFA. It would also like to thank University Campus Suffolk for providing accommodation and associated service at no cost to SIFRE.

He invited questions and ask the members to accept the annual report and the accounts for 2011-

2012.

A question was asked about the minimal amount of interest earned by our funds. The Treasurer reported that interest rates were still at an all time low but he undertook to see if a higher rate of interest could be obtained.

Elizabeth Sugarman proposed and Jan Lelijveld seconded the adoption of the report and accounts. All were in favour.

17. Appointment of Examiner of Accounts for 2011-2012

The treasurer expressed his gratitude to Clive Mees for acting as external examiner of the Accounts and recommended the he be reappointed External Examiner for the coming year. This was proposed by the Treasurer accepted by all.

18. Election of Board Members

Our Memorandum and Articles require one third of the Board (3 Members) to stand down at each AGM and seek re-election if they so wish. (Anita Beresford-Webb was co-opted on 29/02/2012 and will need to stand for election. Two others will also have to stand down and seek re-election if they so choose. Charles Jenkin, David Hussell, Jan Lelijveld, Rose Norgate and Martin Spettigue were all appointed on 21/07/2010. David Hussell is standing down and does not wish to stand for re-election; Charles Jenkin offered to stand down and seek re-election.)

The Candidates were: Anita Beresford-Webb (proposed by WDC and seconded by ES) and Charles Jenkin (proposed by Rose Norgate and seconded by Jan Lelijveld. No other nominations had been received. All members were in favour and both candidates were appointed.

Reference and Administrative Details of the Charity, its Trustees and Advisers

The Charity is an Incorporated Private Limited Company (Company No 2992865) registered on 22 November 1994 and registered as a charity on 6 December 1994. The registered address of the Company is The Inter-Faith centre, The West Building, University Campus Suffolk, Waterfront Building, Neptune Quay, Ipswich. IP4 1QJ.

The Charity has accommodation which is provided by University Campus Suffolk. This accommodation houses a library / seminar room and resource centre, an office, and a store room. It is furnished with fittings previously provided by the Suffolk New College and by University Campus Suffolk and / or donated by other supportive groups.

Structure, Governance and Management

The charitable company is constituted as a limited company and is governed by its memorandum and articles of association.

Membership of SIFRE

SIFRE recognises three categories of membership. These are:

MEMBERS OF THE COMPANY: are those individuals who have registered their membership with the Company and have paid their annual subscription fee.

- They are eligible to attend and vote at General Meetings,
- They can stand for election to the Board,
- They receive all SIFRE's mailings,
- They can attend meetings of the Forum of Faiths,
- They pay an annual subscription of £15.

ASSOCIATES: are individuals who support and engage in the activities of SIFRE but do not wish to be involved in the running of the Company.

- They will receive all SIFRE mailings except Company Members' mailings,
- They can attend but not vote at General Meetings,
- They can attend meetings of the Forum of Faiths,
- They will pay an annual subscription of £10.

AFFILIATE GROUPS: are established faith groups and other organisations who wish to be involved in Inter-Faith activity.

- They will receive all SIFRE mailings except Company Members' mailings,
- They will be invited to appoint two of their number to serve on the Forum of Faiths,
- They will pay an annual subscription of £25.
- They can attend but not vote at General Meetings.

All categories of membership showed little change this year. A list of Members, Associate and Affiliate bodies is appended to this report.

The Board of SIFRE

The Board of the Suffolk Inter-Faith Resource comprises up to 9 members who are elected by the Company Members at the Annual General Meeting. Board members normally serve for a period of 3 years, one third of the Board standing down each year. Those who stand down may seek re-election to the Board at the AGM. The Officers of the Board are appointed at the first Board Meeting following the AGM. The Board met five times in 2012 – 2013.

All the meetings were quorate.

SIFRE Staff

In 2012-2013 SIFRE continued to employ one member of staff who acted as an admin assistant and resources officer.

The volunteer team of 2 Faiths Officer together with various other volunteers have assisted in the delivery of SIFRE's programme

SIFRE continued to be housed in a suite of three rooms in the West Building of UCS. These provided a library / seminar room, an office and a store room. The accommodation, designated 'The Inter-Faith Centre' is used for some of SIFRE's activities and some conducted jointly with the East of England Faiths Agency. SIFRE members are often employed by EEFA for the delivery of commissioned events.

The Resources Officer (Anna-Marie) has represented SIFRE on a number of committees as well as being the presence in the Inter-Faith Centre. Anna-Marie remained the telephone voice of SIFRE and "keeper" of the Centre. Apart from acting as receptionist and assisting other members, she has been responsible for checking books in and out of the library, recording the borrowing of resources and generally keeping things ship-shape.

Rose Norgate has continued as Faith Officer in Waveney and Barbara Mayhew has been representing SIFRE in a variety of countywide networks. David Capey remained the voluntary Executive Officer.

SIFRE's staff continued to be involved in statutory committees and it values the networking and awareness raising potential of this involvement. In particular, SIFRE representatives serve on various committees on diversity and equality.

SIFRE now receives no core funding income from other bodies. Its only income comes from membership fees and donations, from the sale of its Handbook and the Diversity Game, and from tutors working for EEFA who choose to donate their earnings to SIFRE.

Inter-Faith Week activities and the 2013 Holocaust Memorial event were arranged by EEFA (commissioned by SCC) with significant input from Michelle Lockwood, an intern / project student provided by the Events Management Department of University Campus Suffolk.

The day to day work of SIFRE continued to be conducted by two full time voluntary staff who work from home, and one part time salaried staff who work from the SIFRE Centre. The following staff have been associated with SIFRE in the last year.

Board Responsibilities in Respect of the Financial Statements

Company law requires the Board Members of SIFRE to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the charitable company at the year-end and of the net incoming/outgoing resources of the charitable company for the year then ending. In preparing these financial statements, the Board Members are required to

- Select suitable accounting policies
- Make judgements and estimates that are reasonable and prudent
- □ State whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements

□ Prepare financial statements on a going concern basis unless it is inappropriate to assume that the company will continue on that basis

The Board Members are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable it to ensure that the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

External Examiner

In accordance with the requirements of the Companies Act 1985 a resolution proposing that Clive Mees be reappointed as external examiner of the Company will be put to the Annual General Meeting.

Objectives, Activities and Achievements

The purpose of the charity is to advance public knowledge and understanding of the teachings, beliefs, traditions and practices of the different religions and philosophies (including their distinctive features and common ground) of communities in Britain and in particular in Suffolk and East Anglia.

In Lowestoft and the Waveney District, our SIFRE Circle has continued under Rose Norgate's leadership. The SIFRE Circle has been meeting regularly and they were involved in Inter-Faith Week activities, the Christmas Tree project in Beccles and in Holocaust Memorial Day in Lowestoft.

In Bury St Edmunds, the reading group, study group has continued to flourish. Martyn Gienke has now retired and withdrawn from the group.

In Bealings, Jan lelijveldt leads a Circle which meets on a regular basis to discuss a variety of topics.

Our ongoing work with the hospitals and our support for their developing multi-faith Chaplaincies is particularly important.

SIFRE staff have continued to serve on numerous statutory and voluntary sector committees including the Suffolk Joint Diversity Working Group; the Mayor of Ipswich's Civic Celebration of Community; Ipswich Hospital's Respecting Diversity User Group (including the Hospital's Celebration of Faiths event); the Forum of New and Emerging Communities; the Hate Crime Steering Group; the Traveller Support Group; the Standing Advisory Council for Religious Education; the Waveney Community Cohesion Partnership; the University Campus Suffolk Equality and Diversity Committee; and the Police Diversity Board; the West Suffolk Domestic Abuse Forum and the Safer Communities forums and the Congress Organising Group.

SIFRE hosted a Seniors' Inter-Faith Tea Party on the first Tuesday of each month, These are now held either in the Inter-Faith Centre or at the home of one of the group.

Our inter-faith handbook remains one of our flag ship products. The new fourth edition, re-titled 'A Handbook of Faiths', produced and published in conjunction with the Festival Shop in Birmingham, continues to sell well. Also, our redesigned game 'Diversity', available in a smart A4 sized box with a folding A3 sized playing mat, has been purchased by all sorts of organisations from all parts of the UK. Sadly, the Festival Shop ceased trading in 2010 and we are now the sole distributors of these products.

SIFRE is only as successful as those who work for it as staff and tutors make it and the Board would like to acknowledge the parts played by an incredible number of people over the last year.

Financial Review

I present the Annual Accounts for the year 2012-2013. As an overview, I report that apart from our loss of significant external funding which was used to pay our salaried staff, this year's account very much mirror previous years. In terms of income and expenditure there is nothing which I need to bring to your attention. I would however wish to point out that our Unrestricted Fund gives me hope for the future. In this year, our non salaried income exceeded our non salaried expenditure by just over £2000. I will be returning to this shortly. The Board agreed to transfer £25,000 from our reserves of £30,000 to our Salaries fund, and so we finished the year with £13.5K in this fund and we carry a reserve of £5K.

However, I must remind you that some of our funds are held as stock (recorded at its wholesale price). Our games, we purchased from the Festival Shop at its demise for £7.50 each — we sell them at their original price of £30. The Mats we purchased at £10 and we sell at £27.50. The Handbooks we purchased at £1 and we sell at £5.95. In all the wholesale price of our stock was £11.235 and the retail value was £46.5K. These figures include the cost of the Faith Cards which we bought at £1 a pack and

occasionally sell at £5.95 a pack. More often than not though we give these away as advertising freebies.

I return to our Statement of Financial Activities (S.O.F.A.). I have produced a simplified SOFA which is included at the back of the Annual report. It traces in columns 1, 2 and 3 the fortunes of SIFRE for 2010-2011, 2011-2012, and 2012-2013. Column 4 is the budget for 2012-2013 which I prepared much earlier in the year. Column 5 is a Budget for 2013-2014 which assumes that our Admin Assistant remains in her post till March 2014.

The Board however has, since the end of the financial year 2012-2013, taken the view that it ought to preserve its contingency reserve at above the £5K it agreed in the previous year. Consequently and after considerable discussion, it voted to terminate the employment of our Admin Assistant. We have subsequently commenced redundancy procedures and our Assistant's post will terminate on 30th September 2013.

Columns 6 and 7 demonstrate how we should fare in 2014-2015 and in 2015-2016. I just want to draw your attention to the projection that in these last two years our unrestricted fund trading profit will amount in each case to about £6K.

This is based on an assumption that we can sell 50 each of the game, the mat and the handbook in each year. It also presumes we can stimulate our membership. This last year our membership income amounted to £1.710. (I suspect that though many of our members are inactive within SIFRE; they see it as a worthwhile cause in need of support) If everyone on our emailing list was a paid up member/organisation, that figure would have been £3,450. We have some good events, we offer Suffolk a good service. If we can sell ourselves, we have every possibility of stabilising as self funding organisation.

The Board would like to register its appreciation to University Campus Suffolk for providing accommodation and associated service at no cost to SIFRE.

The Future

The Board has been examining proposals as to how it should respond to its reduced income. These proposals, presented last year, and which remain to be fully implemented are tabulated below. It was intended that responsibilities be subdivided such that activities can be more easily and transparently managed. Its working document therefore allies its activities to those it undertakes with EEFA.

SIFRE commits itself to doing those things it believes in and it intends to play a significant role in organising and running events during National Inter-Faith Week (this week was inspired by 'Face to Face and Side by Side', a government report).

SIFRE has slimmed down its operation and as from 1st October 2013, it will be a totally voluntarily run organisation. It is thus less susceptible to the financial ups and downs of the country and county and can continue to deliver a professional service to the people of Suffolk for very little cost and with little fear of financial doom.

SIFRE survived 2012-2013 with reduced staff but nevertheless managed to present a very acceptable programme of events for all of those interested in inter-faith issues.

SIFRE will continue to nurture its study groups and further develop its Forum of Faiths. It will continue to be a membership organisation. It will encourage the growth of its Faith Officer Team and it will endeavour to continue to have a presence in County, District and other sector committees and panels whenever and wherever input is requested. SIFRE looks to new ways of ensuring the faith communities have a voice. It is hoped that it will be able to provide, on a casual basis, volunteer speakers to voluntary groups who have little or no funds at their disposal. (These groups – churches, cubs, scouts, etc - have previously been subsidised by EEFA)

Over the years, SIFRE's range of activities and involvements has been increasing. Besides running an extensive teaching and training programme, running study groups and organising Forum of Faiths meetings, its staff serve on some numerous interagency committees. They have found it increasingly challenging to attend to all of these commitments. At the present time, all sections of the voluntary sector feel challenged by financial instability. Whilst the Board of SIFRE remains optimistic, it realises that it must look seriously at its activities and involvements and it has started to develop its strategy for what is now looking like an extensive period of economic recession.

The Board wishes to express its gratitude to our new landlords at University Campus Suffolk for their willingness to continue to accommodate us and to the staff of University Campus Suffolk who have made us so welcome, to the members of UCS Estates team who are always friendly and helpful.

Finally it wishes to pay tribute to two of its members who have died during the year.

Ann Barbanell died on $19^{\rm th}$ April 2013 aged 90. She described herself on her membership registration forms as a fossilised musician.

Elizabeth Watthews died on 29^{th} March 2013 aged 81.

Both have faithfully supported SIFRE since its inception.

INTER-FAITH CONSULTANT'S REPORT 2012-3

2012-13 has been a year of catching up and moving on. We have continued our efforts to make our premises fit for purpose and we have explored new ways of functioning to meet current needs.

- 1 Sorting records and resources an onslaught has been made on the boxes of records in the store room. The task of weeding out and sorting is still ongoing but we are making good progress. Our other resources are also being checked and reordered.
- 2 Reordering the library advice was sought from various people about the sorting out and displaying of our large collection of books. They have now been catalogued and we hope to have the full list available on-line shortly, with links to UCS and County libraries.
- "Open the Box" project with a grant obtained through SACRE we piloted a scheme through which schools could hire boxes of books and artefacts to support RE. It includes faith boxes for Buddhism, Christianity, Hinduism, Humanism, Islam, Judaism, Paganism and Sikhism. Liz Bennett, the co-ordinator, is continuing to run the project.
- 4 "Facing up to Faith in Suffolk" we have been compiling this on-line book with a view to highlighting facts about the faiths of Suffolk, and including more detailed information for those who need it. A wide range of people have also contributed their personal stories and there are other articles for inspiration and reflection.
- Supporting our volunteers- the team of SIFRE Faith Officers has been evolving into a strong and resourceful group who will represent SIFRE in the wider community and we are also in the early stages of creating a rota of people to staff the Centre on a regular basis and who are willing to act as "Readers/advisers" in the library/seminar room.
- Strengthening our links –we continue to build our connections with the wider community and are trying out different ways of publicising our seminars and other events. We hope to attract the attention of students and staff to our facilities and programme and are pleased that they are becoming more involved with us in the local arrangements for established events like HMD and Inter-Faith Week.

INTER-FAITH WEEK IN SUFFOLK 2012

This was the fourth year of this National Event and we arranged a full programme of activities:

Inter-Faith Reflections at Ipswich Hospital – SIFRE was invited to attend a planning session as a result of which we supplied 2 x 12 faith poster exhibitions for the chapel and elsewhere. We also provided speaker to do daily reflections which were delivered live in the Chapel and were recorded by Hospital Radio for inclusion in their daily programmes; 8 SIFRE people plus 2 chaplains participated.

Saturday 17th Visits to places of worship with Mayor and others in police minibus, courtesy of Liz Pettman. This was very worthwhile but they were constrained by time. Next year it would be better to extend into the afternoon.

Sunday 18th BBC Radio Suffolk – Martin Spettigue participated in the religious programme.

Sunday 18th. 6:00 PM – Mayor's Celebration of Community at St. Peter's by the Waterfront. The theme was "A religious History of Ipswich" and it was divided into 3 parts – Pagan History up to King Raedwald, Protestant and Catholic Martyrs, and Faiths active In Suffolk today. We put up an exhibition which was there for most of the week. We were made very welcome.

Monday 19th 5:00 PM-7:00 PM – A 'Diversity Game 'session for Suffolk Coastal was held at the Angela Cobbold Memorial Hall in Bealings. About 29 attended including young people from St Andrew's Melton, representatives from parish council; and district and county council, police, Suffolk Carers and faith representatives.

Tuesday 20th 10:00 AM – 12:00 PM – We hosted an 'Any Questions' session for 14 pupils from Stradbroke High.. The panel consisted of Buddhist, Christian (3), Hindu, Humanist, Muslim and Sikh tutors. We dealt with further questions received from the pupils by email and were able to include a Jewish perspective.

Tuesday 20th 2:30 PM – 4:00 PM – 9 or so attended the monthly SIFRE tea party.

Wednesday 21st – Community Chaplaincy (for West Suffolk) Consultation no 2 attended by around 25 people. Canon Duncan Green spoke of his experiences as Co-ordinator of the Olympic Games and Canon Andrew Todd outlined training possibilities in relation to different modes of Chaplaincy. Mark Jepson from Havebury Housing, Ian Mathers from West Suffolk College, Selene Borda from Newmarket Street Pastors and Jim Platts from EEFC agreed to join the Development Group.

Thursday 22nd – A 'Diversity Game' session for Waveney District was held at the Café Grand in Lowestoft. It was opened by Frank Gardiner (WDC) and attended by 10 others including Baha'i, Christian, Hindu, Humanist and Muslim – in particular 2 more Muslim women who have been involved with a women's group, and who will keep in touch.

Friday 23rd – Interfaith storytelling for primary children. We ran two sessions at St. Peter's by the Waterfront which were attended by 14 children from the Oaks Community School, and 54 from Bramford Primary School. The sessions consisted of interactive stories from Buddhist, Hindu, Christian, Jewish and Muslim traditions and a Sikh wedding.

Saturday 23rd – "They suffered for their faith" guided tour in Ipswich with Evelyn Hewing from Ipswich Blue Badge Guides. This attracted 14 people.

Monday 24th – A 'Diversity Game' session for West Suffolk was held in West Suffolk House. It was attended by about 12 including Councillor Gower and a very ecumenically mixed group of people. The game was much appreciated.

Tuesday 25th – UCS / SIFRE Third Annual Faith Lecture. 'Equality, human rights and religion or belief: time to get out of the courtroom?' – was delivered by Alice Donald (Senior Research Fellow in the Human Rights and Social Justice Research Institute at London Metropolitan University)

Inter-Faith Exhibitions were held throughout the week in Woodbridge Library (much interest generated), Felixstowe Library. Grafton House and Endeavour House.

Interfaith Week this year was followed by Christmas tree Festivals in the Friends' Meeting House in Beccles and in St Mary le-Tower in Ipswich.

In addition – Martin Spettigue represented SIFRE at a reception at Lambeth Palace on Thursday 21st.
